# Information We Collect About You

We collect information about you from:

- Information we receive from written, on-line or oral applications or other forms such as name, address and social security number;
- Information about your transactions with us such as policy information and payment history; and
- Information we receive from a consumer reporting agency such as credit history.

## Information We May Disclose About You

We may disclose all of the information we collect, as described above.

# **Parties Who Receive Information From Us**

We may disclosure information about you to these third parties:

- Financial Companies, such as insurance companies, financial institutions, and consumer reporting agencies; and
- Non-Financial Companies, such as our data processors, document destruction companies, and companies that perform marketing services on SIS Insurance & Financial Services' behalf.

SIS Insurance & Financial Services does not share or sell any customer information to any non-affiliated third party, other than those with whom we contract for assisting us in conducting business. Therefore no opt out is necessary for that type of information sharing.

Customers may have limited opt-out rights related to marketing from SIS Insurance & Financial Service's affiliates. Please see the opt-out option described below.

# Affiliate Marketing Opt-Out Option

SIS Insurance & Financial Services is providing this notice, as required by Federal law, to inform you of your choice to limit marketing from our affiliates. Our affiliates include companies with a Sunmark name, such as Sunmark Federal Credit Union.

You may limit our affiliates from marketing their products or services to you based on the information that we collect and share with them. We may share your personal information, including your policy history with us, however, we do not share your creditworthiness information with our affiliates.

Your choice to limit marketing offers from our affiliates will apply for the duration of your relationship with SIS Insurance & Financial Services, unless you inform us that you do wish to receive these marketing offers. If you have already made a choice to limit marketing offers from our affiliates, you do not need to act again. You will need to act again if you decide to engage in any new or additional relationships with SIS Insurance & Financial Services.

#### **Disclosure of Information to Parties that Provide Services to Us**

We may also disclose information about you under circumstances as permitted or required by law. These disclosures typically include information to process transactions on your behalf, conduct the operations of our company, follow your instructions as authorized, or protect the security of our financial records.
